The organization provides support for the construction on new homes and schools to serve the many children that are still being rescued from trafficked lifestyles. In 2020, more than 100 children were cared for through this program.

Touch A Life provides support to The Place of Rescue Aids Center and Orphanage in Cambodia. The Place of Rescue is a safe haven for families that have been stricken with the aids virus. 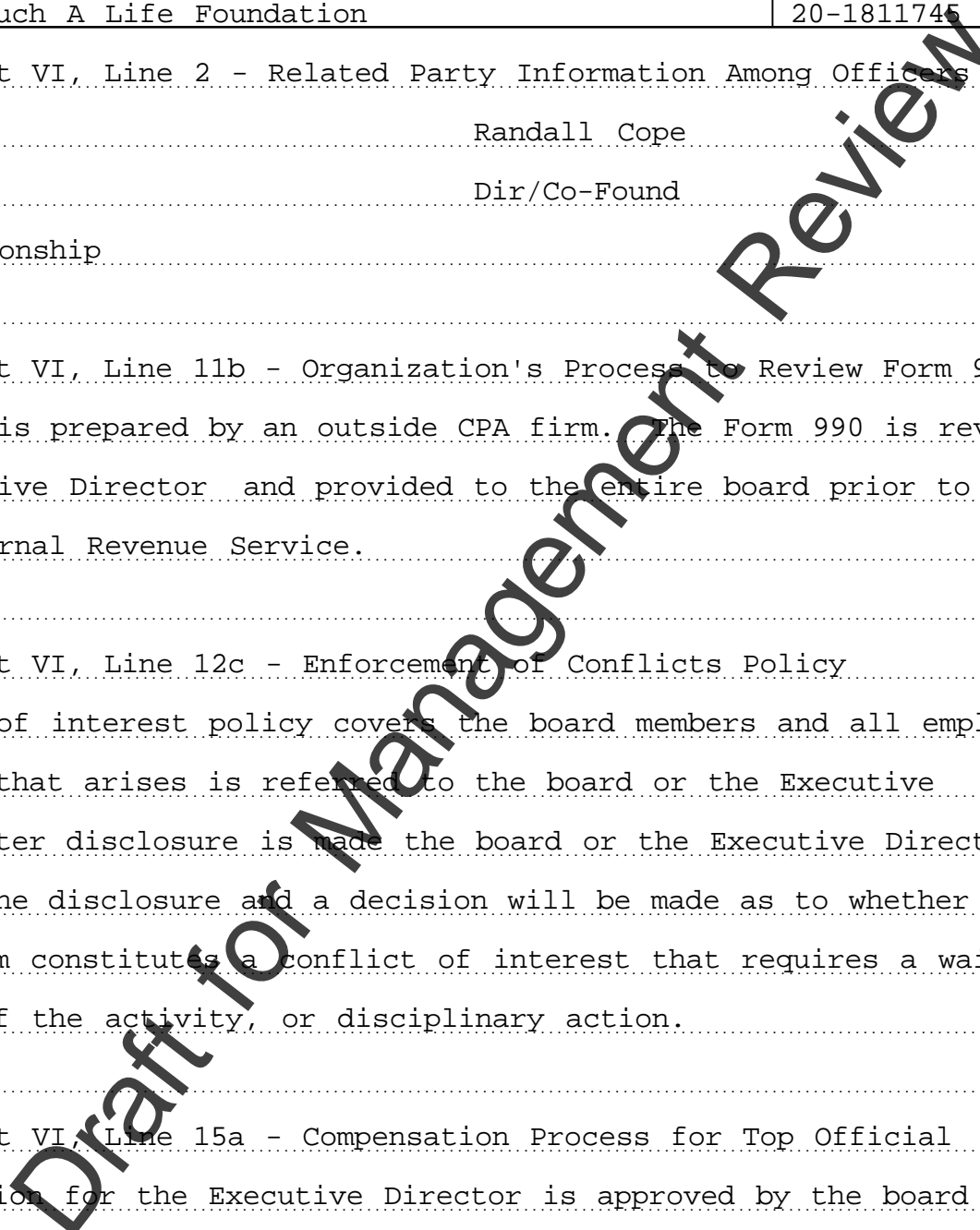
