Together they operate a long-term facility where they provide food, shelter, education, medical care, and art healing program. To date, Touch A Life has supported over 130 children and young adults, and they have graduated 20 young adult survivors from Ghanaian colleges and universities.

Touch A Life provides support to The Place of Rescue Aids Center and Orphanage in Cambodia. The Place of Rescue is a safe haven for families that have been stricken with the aids virus.
